## **Board Meeting Minutes**

Secretary's Report April 20, 2021

#### I. President Call to Order

### II. Corporate Reports

**E.** Update on the County proposed increase to the Fire Assessment Fee – Members reported that Sumter County commissioners voted unanimously not to increase the current maximum fire assessment cap of \$125 per improved land parcel.
