Annual Assessment Don't Get Behind <u>It Costs More!</u>

Everyone goes through tough financial periods when the bills start accumulating and the light at the end of the tunnel seems to be getting dimmer and dimmer. But, as is most often the case, those times pass and through determination and careful financial planning we are able to get back on our financial "feet" once again. During those challenging periods it is often tempting to avoid meeting certain financial obligations in order to meet others. However, when deciding which bills to "juggle" and which to pay remember that your annual association dues are just as important as your mortgage payment. If you don't pay your mortgage, you will eventually lose your home. Likewise, if you don't pay your annual assessment, the association has the right to secure the debt. More importantly however, is that should you let your assessment become delinquent, in order to bring your account current, you will have to pay more than the original assessment amount. Late fees, interest charges and if applicable various administrative and legal fees must also be paid. The bottom line: Don't juggle your annual assessment payment. Pay on time and avoid paying more in the long run.

The HOA Board of Directors has been made aware of dogs roaming Tracy's Point. This is a reminder that Household Pets are to be kept confined to the residence or leashed outside the residence. Abiding by the following county ordinance will not only keep street and yards Poop Free, it will also alleviate unnecessary stress to animal and owner caused by having an animal impounded.

In Sumter County, Florida, residents and visitors are subject to the Code of Ordinances for Sumter County, Florida. Pursuant to Chapter 4, Animal Control, Section 4 -10 – Dogs and Cats Running at Large – a dog owner has a duty to keep dogs from "running at large" when in or upon any public street, sidewalk, or other public property of another. A dog owner must keep his or her dog pursuant to Section 4 – 4 – Definitions under Direct Control which means restraint or control by a fence, leash, cord, or chain sufficiently to restrain the dog.

Holiday Coffee Recipes

Here are some coffee recipes you might be able to use for the holidays. To prepare the coffee recipes: mix in food processor or blender until you have a fine powder. For all the coffee recipes use 1 to 2 spoonfuls to one mug of hot water (to desired taste).

BAVARIAN MINT

- 2/3 cup instant coffee
- 1 cup sugar
- 1 tsp. dried mint leaves
- 2/3 cup non-dairy creamer (you might have to turn the mint leaves into powder) CAFE' L'ORANGE
- 2/3 cup instant coffee
- 1 cup sugar
- 1 tsp. dried crushed orange peel
- 1/4 tsp. cinnamon
- CAFE' MOCHA
- 2/3 cup instant coffee
- 3 TBSP unsweetened cocoa
- 1 1/3 cups sugar
- 1 cup non-dairy creamer
- 1/4 cup nonfat dry milk
- CINNAMON-N-SPICE
- 2/3 cup instant coffee
- 1 1/3 cup sugar
- 1/2 tsp. cinnamon
- 1/2 tsp. nutmeg
- 1/2 tsp. allspice
- TOFFEE COFFEE
- 1 cup instant coffee
- 1 cup non-dairy creamer
- 1 cup brown sugar
- CAFE' VIENNA
- 1 cup instant coffee
- 1 1/3 cups sugar
- 1 1/3 cups nonfat dry milk
- 1 tsp. cinnamon
- CAFE' ORANGE CAPPUCCINO
- 1 cup instant coffee
- 1 1/2 cups sugar
- 2 cups nonfat dry milk
- 1 tsp. dry orange peel

<u>Great Holiday Recipe</u> Orange Gingerbread

Ingredients:

1/2 Cup of butter
1/2 Cup of sugar
1/2 Cup of light molasses
1 Egg, beaten
Grated rind and juice of 1 orange
1/2 Cup of cold tea
1 3/4 Cups of pastry flour
3/4 Teaspoon of soda (baking)
1 Teaspoon of ginger

Directions:

Cream the butter, add the sugar and mix until fluffy. Add the molasses, beaten egg, rind and juice of the orange and beat well. Add the tea and flour which has been sifted with the soda and ginger. Bake 30 minutes at 300°F to 325°F. This is the most delicious and tender gingerbread imaginable with a subtle flavor.
