Our Annual Assessment

Each month at bill paying time we take out our check books and pay a multitude of monthly bills: credit cards, car payment, mortgage, etc. However, one of the least understood bills that we pay is our annual association assessment.

Just where does our money go?

Every year the Board approves a budget for the upcoming fiscal year. The budget is then mailed to all homeowners for their review. The budget lists all the anticipated expenditures for our association. Those expenditures include insurance for the two lots owned by the association, common area maintenance costs, and non-discretionary administration costs such as notices and newsletters, postage, street lights,

property tax, etc.

So, when you write out that annual assessment check, remember that it covers many items necessary to ensure that our association meets its regulatory requirements and works to enhance property values.

Recipes

Stuffed Ham Rolls

2 cups seasoned stuffing croutons 1/2 cup boiling water 2 teaspoons plus 2 teaspoons butter or margarine, divided 8 fully cooked ham slices (1/8 inch thick) 8 slices Swiss cheese 1 egg, beaten 1 teaspoon water 1/2 cup dry bread crumbs

In a bowl, combine stuffing, boiling water and 2 teaspoons butter. Cover and let stand for 5 minutes. Top each ham slice with a cheese slice. Place 1/4 cup stuffing off-center over cheese. Roll up and secure with a toothpick. Combine egg and water. Roll ham rolls in egg mixture, then in bread crumbs. In a large skillet, sauté ham rolls in remaining butter for

4-5 minutes or until golden brown, turning once. Discard toothpicks. Yield: 4 servings.

Chicken Royale

This is an extremely easy and elegant dinner for guests or family:

1 8oz bottle French Dressing

1 large can whole berry cranberry sauce

1 pkg. dry onion soup mix

1 large chicken (quartered or pieces)

Place chicken skin side up in roasting pan. Mix first 3 ingredients together and pour over chicken. Cover tightly with aluminum foil and bake 375 degrees for one hour.

Remove foil and continue baking 30 - 45 minutes until browned.

Serve over white rice. Serves 4.

Add a salad and dessert and you have a wonderful company dinner. (Can be made one day ahead and refrigerated, skim fat and reheat in oven or microwave.)
